PUBLIC NOTICE IS HEREBY GIVEN in compliance with Section 21660.2 of Title 27 of the California Code of Regulations that the Local Enforcement Agency (LEA) will be conducting an informational meeting regarding a proposed solid waste facility permit revision for the Monofill Facility (SWIS No. 13-AA-0022) located at 3301 West Highway 86, Brawley, CA, 92227 (about 13 miles, east of Westmorland, on Hwy. 86)..

Purpose: The meeting is being held to provide information about a proposed revision to the Solid Waste Facility Permit for the Desert Valley Company Monofill. The public will be offered the opportunity to comment and to ask the LEA questions about the application package that was accepted for filing on April 3, 2025. The LEA's preliminary determination is that the proposed changes require a permit revision. A summary of comments from the informational meeting and any written public comments received by the LEA prior to the meeting will be included with the permit revision application package submitted to the California Department of Resources, Recycling and Recovery (CalRecycle) for consideration.

Project Description: The proposed permit revision reflects the following changes to the design and operation of the Desert Valley Company Monofill:

- Increase in permitted disposal footprint from 28.9 acres to 62 acres.
- Increase in expected closure date from 2025 to 2053.
- Increase in the maximum elevation of the landfill from 59' below average sea level to 55' below average sea level.


