


2024 Heat-Related Illness Update

Imperial County Public Health Department Surveillance: 5/1/2024-9/20/2024

Heat-Related Illness Surveillance

The Imperial County Public Health Department collects data in collaboration with El Centro Regional Medical Center (ECRMC), Pioneers Memorial Healthcare District (PMHD), and the Imperial County Coroner's Office to monitor heat-related illnesses and deaths due to environmental heat exposure. This report includes the most up-to-date data on heat-related illnesses and deaths in the county.





From May 1 to September 20, 2024, a total of 138 heat-related illnesses and 10 probable deaths* were reported by local hospitals and the coroner's office. Of the total number of heat-related illnesses reported (n=138), 70% were male, 77% Hispanic, and 93% reported being outdoors during onset of illness. Among the cases with known age (n=138), the age range was 12 to 92 years old, with a median age of 48 years. Residency for those with available information: 26% homeless, 17% out-of-county residents, 54% Imperial County residents and 3% unknown.


A total of ten probable deaths due to environmental heat exposure were reported and are pending confirmation from the coroner's office. Among the deceased cases, 70% were male. Age information was available for eight of the ten reported cases, distributed across the following age groups: 0-17 years (12%), 50-64 years (63%), and 65 years and older (25%). 
Cool Centers & Hydration Stations
